10 Notes

10.1 Fees for official confirmation of receipt of the completed registration depend on state law. A separate fee assessment is made if this is the case.

10.2 Collectors and carriers of wastes have to carry a copy or printout of this officially confirmed registration along during exercise of their activity if they are not exempted from the obligation to do so. If the authority has not yet confirmed the registration, this is to be annotated by the discloser on the copy or printout. In this case, the annotated copy or printout of the registration is to be carried along. Specialized disposal companies also have to carry along a copy of the currently valid certificate. EMAS businesses must also carry along a copy of the currently valid registration certificate.

10.3 The registration must be resubmitted if essential information changes. Fields 1.1 through 1.4 and 2 through 6 are essential information.
